We are still in a holding pattern for Joslyn's replacement.**Partner Biologist-** Kyle relayed that we are still waiting to hear about the status of the RESTORE grant. Colorado Springs Utilities are working on addressing watershed concerns in the area. They will be paying for watershed restoration.**DM-**see attached. Marisa spoke with Ross Herzog's office. The county contract is signed and is ready for the 2024 season.**Old Business:** Greg has begun to work on editing the by-laws. The Board will have the long-range plan updated before the end of the year. We are still looking at ways to expand Envirothon into Park County. There are no scholarship applications yet from either county. Marisa will reach out to Park County CSU extension asking for help getting the word out about Envirothon and the scholarship.**New Business:** We are holding the week of October 7-12 open for some type of annual meeting, topic TBD. We have two interested students who would like to attend Camp Rocky. The rate is \$475 per camper. Marisa is in the process of setting up HOA talks. Cripple Creek Mountain Estates and Colorado Mountain Estates will have priority. Marisa will arrange a talk at the Florissant Grange to handle the HOAs on the north side of Highway 24.
