### **Envirothon Update by Mark Platten**

Mark Platten of Teller County CSU Extension gave an overview of the newly revitalized Envirothon. He will be the new director in rebuilding this statewide program. CACD along with CSCB and NRCS will work with CSU in order to build this program. Woodland Park will send two teams this year. Rose Banzhaf, our volunteer Envirothon coordinator, is helping with this task. Each student who participates in the competition will automatically receive a \$1,000 scholarship to CSU and the winners and second place will receive additional money toward agricultural program majors at CSU. The competition has been moved to the CSU Spur campus in Denver. The winning team will attend Nationals in New Brunswick, Canada.

### **Update from Mariah Hudson**

Mariah Hudson, El Paso County Conservation District Manager, introduced herself and gave an update on their programs.

### **NRCS Report**

Chris Smith, NRCS Soil Conservationist, gave an update on the Woodland Park office. The NRCS has facilitated some conservation easements in the Shawnee and Como areas of Park County. The office has high tunnel projects approved and has three more site visits with high tunnel requests. There is a cost-cap associated with these projects. The Howard Stone Ranch forestry portion of the project is up and running. They are waiting to hear about additional funding for the wetland part of the project. Twelve acres have been completed on the Sanborn Ranch Project. The 403-fire burned up to the edge of the project.

Kyle Deschenes, partner biologist, is working on wildlife and forestry projects on Crystal Peak in Park County.
